Up for review:

Overview: As per the Directors' Handbook, the Awards portfolio falls under the duties of the Secretary. There are two different groups of awards, Support4Sport Awards, and NSAWA Awards.

Support4Sport Awards

- 1. Requests for nominations will go out in January every year. This is done through a google form created by the PSO Coordinator.
- 2. The form will be emailed to all NSAWA members by the Secretary. It will also be posted on social media.
- 3. Nomination deadline is March 25th; unless otherwise stated by Support4Sport.
- 4. A committee will be formed (taking care to avoid any conflict of interest wherever possible) including the Secretary, one coach, one official, one board member, and the PSO Coordinator to review nominations and determine if any meet the requirements sent out by Support4Sport.
- 5. The PSO coordinator will communicate the results to Support4Sport.
 - Junior Athletes→ under 20 years old
 - Senior Athletes→ 20 years old and older

NSAWA Awards Process:

- 1. A committee shall be chosen of not less than three (3) members and not more than (5) members, including the Secretary, taking care to avoid any conflict of interest wherever possible. This committee is responsible for planning the awards gathering.
- 2. The awards gathering is planned and conducted each year within 60 days of the end of the year. No later than July 31st.
- 3. The awards shall be, unless otherwise stated in the individual award, for the period of June 1st May 31st.
- 4. The Awards committee shall solicit nominations from the members of NSAWA for each of the categories at least 30 days before the ceremony.
- 5. A sub-committee including one coach, one official, one board member, and the PSO coordinator shall discuss the nominations and determine if there is a likely candidate that has not been nominated. Any additional candidates, with rationale, shall be added to the list.
- 6. From the nominations and the rationale, the committee shall then put forth their recommendation to the Executive of NSAWA.
- 7. The committee can recommend an exceptional award if they deem one is merited.
- 8. The Executive shall review the recommendations and ensure the information forth-coming is complete.
- 9. The Executive can:
 - a. Contact the potential candidate(s) for further information.
 - b. Request further information or a different candidate from the Awards committee.
 - c. Approve the awards as recommended.
 - d. Recommend an exceptional award to the Board of Directors if they deem one is merited.

| Club Coach of the Year Award This award can be nominated by any member of NSAWA and is given to the coach who has contributed enhanced development of their athletes and the sport within the current season. The successful candidates also have contributed to the development and enhancement of NSAWA regionally and nationally. | Long-Service Award This award is presented annually to not more than four (4) individuals who have been a member of and contributed to the development and organization of NSAWA for a minimum of twenty (20) years. | SSNS School Coach of the Year This award is presented annually to an SSNS coach who has contributed to the enhanced development athletes and the sport. Examples of criteria to be considered but not limited to: Has participated in SSNS tournaments as a team or a host; Has had a positive effect on the athletes and their successes; Has made a difference in the promotion and support of the sport; Has made an impact on the development of their athletes; Has shown commitment to athlete recruitment and retention; Has helped their athletes reach new heights; Accomplishments in the respective SSNS year; Has gone above and beyond for the support of athletes, co-coaches, and the sport; | of their |

| Official of the Year Award This award is presented annually to an official (referee or drawmaster) who has dedicated considerable time and effort to the wrestling community and without whom the sport would not be the same. Any member of the wrestling community can nominate an official who they believe to be worthy of receiving this award. Criteria to be considered by not limited to: □ Participation in tournaments, training camps, and other wrestling events; |
| Positive attitude on and off the mat; Encourages the growth of officials within the organization; Promotes wrestling; Goes above and beyond in their duties. |
| Outstanding Development Wrestler Award This award is presented to U13/U15 developing athletes of either gender. Examples of criteria to be considered but not limited to: Has shown commitment to their own development by regularly attending and fully participating in practices, competitions, and training camps. Has demonstrated respect and a positive attitude while having fun. Has demonstrated sportsmanship, fair play, respect toward coaches, officials, volunteers, opponents, teammates, and the wrestling community. Has demonstrated enthusiasm for the sport, on and off the mat. Has demonstrated work ethic, teamwork, discipline, and perseverance. |
| Parent/Guardian of the Year Award This award is presented annually to an individual of the wrestling community who has dedicated considerable time and effort to the successful development and support of athletes, clubs, events, wrestling, and NSAWA. The following criteria will be considered but not limited to: Has worked in any aspect of the wrestling community and without them, the sport would not be as successful; Has given up a substantial amount of time to volunteer with the sport of wrestling, either/or at an SSNS level or NSAWA level; Has promoted the sport, through assisting or setting up Milk Fairs, tournaments, training camps, etc.; Has assisted or participated in organizing events, training camps, tournaments, canteens, etc.; Has managed or assisted in managing clubs; Has attended practice, training camps, and tournaments as a support person; Has provided administrative duties, i.e., bookkeeping, marketing/advertising, fundraising, promotions, sport development, governance, organization development, event planning, or educational support; Has been an inspiration and is a positive role model for participants and others; There is no requirement to be a paid member of NSAWA. |

NSAWA Division Awards by Statistics

- An award will be presented to the top successful athlete in each division;
 U21 Male/ U21 Female to U7 Male/Female
- 2. These awards will not have nominations. Statistics for placement at tournaments are kept yearly and the awards will be based on these statistics.

3. Points will be given to each athlete depending on their placement at eligible tournaments (see list below). The following rubric will be used when assigning points:

4. In the event of a tie between two athletes, the award will be determined by using the following tie-breaking criteria.

Each step shall be applied until the tie no longer exists.

- The athlete with the most 1st place finishes
- The athlete with the most 2nd place finishes
- The athlete with the most 3rd place finishes
- The athlete with the most 4th place finishes
- The athlete with the most 5th place finishes
- The athlete with the most 6th place finishes

If a tie still exists, the award will be given to both athletes.

- 5. Eligible tournaments:
 - SSNS tournaments
 - WNS tournaments
 - Tournaments hosted in the Atlantic Provinces
 - Nationals
 - Canada East

6. Athletes will only receive points for their actual weight and age category.

^{*}Exception: Other tournaments where ten (10) or more WNS athletes competed will be included.
